

## **Admissions Policy**

### **Introduction**

A 'Secondary Information for Parents' booklet is published by the Local Authority each year, giving details of the Local Authority's co-ordinated admissions arrangements. This is available from Local Authority Offices, on the Staffordshire County Council website and on request from the Local Authority directly.

In the Autumn term of each academic year, parents/carers of children in Year 6 in the county's primary schools should receive a letter reminding them that they now need to apply for a secondary place.

All initial correspondence and any reminders of the deadline for applications will come through the child's primary school. Parents/carers should, therefore, ensure that the contact details held by the primary school are up-to-date.

The co-ordination of admissions arrangements for applications into year 7 is undertaken by the Local Authority.

### **Aim**

The aim of this document is to ensure the following:

- Students are admitted to the Insight Multi Academy Trust (IMAT) in accordance with statutory requirements.
- The number of students to be admitted to the schools within the IMAT in any particular academic year is agreed with the appropriate authority.
