### **Drugs Policy & Procedure**

### **Introduction**

The Insight Multi-Academy Trust (IMAT) actively seeks to provide an environment where all members of the community are safe from harm. As such, the IMAT takes a robust approach to any individual or group that violates our behaviour, drugs or anti-bullying policies.

This is a Multi-Academy Trust where human rights are respected; as such the responsibility to maintain high standards of behaviour lies with all members of the IMAT. The IMAT acknowledges its legal duties under the Equalities Act 2010 in relation to all protected groups including Special Educational Needs and Disabilities (SEND) and will always take their circumstances into account.

### <u>Aim</u>

- To ensure that the IMAT takes a whole approach on the issue of drugs as part of its commitment to ensuring the health and safety of all its students.
- To ensure that all sites within the IMAT are a substance, alcohol, tobacco and vape free site.
- To ensure that the IMAT's role in drug prevention and drug education is appropriate to all students' needs.
- To ensure that teachers are confident and skilled to teach drug education through training and support.
- To have clear procedures for responding to drug-related incidents, with sanctions consistent with the school's Achievement and Positive Behaviour Policy.
- To support students to make healthy, informed choices by increasing knowledge, challenging attitudes and developing and practising skills.
- To provide accurate information about drugs, tobacco, alcohol and vapes.
- To seek to minimise the risk that users and potential users face.
- To enable young people to identify sources of appropriate adult support.

### **Key Elements**

Students receive drugs, tobacco, alcohol and vape education in the taught Science curriculum, Personal, Social and Health Education; Relationship, Sex and Health Education, the informal curriculum and through extra-curricular activities. The IMAT actively co-operates with other agencies such as the Community Police, Social Services, Local A, Young Offenders Institution and Health and Drug Agencies to deliver its commitment to tobacco, alcohol, drug and vape education and to deal with incidents of misuse.

### **Definition of a Drug**

A drug is a substance that affects the way in which the body functions physically, emotionally or mentally. For purposes of this policy, by 'drugs' we are referring to illegal substances and also legal substances such as: alcohol, tobacco, volatile substances, over the counter or prescription medicines and legal highs. By drugs paraphernalia we mean items such as cannabis grinders, rolling papers, filters, matches, lighters and pipes etc. It is our aim to help all students to be able to take their place safely in a world where a wide range of drugs exist.

### **Drugs on Academy premises**

The legal definition of school premises includes everything within the property boundaries including buildings, outbuildings, playgrounds, fields and also extends to include other settings such as vehicles, boats, marquees or any venue managed by the school at the time e.g. premises of a school trip or visit.

### **Medicines**

The IMAT has a policy/procedure for the administration of medicines that must be followed for everyone's safety. We follow procedures recommended by DFE and Staffordshire Health & Safety guidelines.

### **Alcohol**

No alcohol may be brought on to school premises or consumed during the course of a school day. Students, parents, carers and visitors under the effects of alcohol will be asked to leave the premises and return at a later date for the safety of the whole school. Parents will be asked to remove their children from the school

### **Smoking**

School premises are a no smoking site at all times. Students are not permitted to bring to school smoking materials, including matches and lighters. In the interests of health and safety, should a student be found in possession of any of these on school premises, they will be confiscated and parents/carers informed. Smoking on or within 200m of the school premises may result in a Fixed Term Exclusion. This also applies to "vaping" and the use of electronic cigarettes.

### Illegal drugs and legal highs

No illegal drugs, legal highs or drugs paraphernalia are allowed to be brought on to, or used on school premises. Bringing any such items onto school premises is considered a serious breach of this drugs policy. Seeking to influence or glamorise illegal drug use or the use of legal highs either in person on school premises or via social networking sites is also considered a serious breach of this drugs policy.

### **Solvents**

The school will ensure that potentially hazardous substances it authorises are stored safely, and students will be supervised if it is necessary that they come into contact with them in the course of their work. Students are not permitted to be in possession of solvents. Bringing solvents or hazardous substances onto school premises is considered a serious breach of this drugs policy.

### Responses to drug related incidents

A drug incident may be any of the following:

- Finding drugs, or related paraphernalia, on school premises
- Possession of drugs by an individual on school premises
- Use of drugs by an individual on school premises
- A suspicion that a student is under the influence of drugs or other substances
- Supply of drugs on school premises

- Individuals disclosing information about their drug use
- Student reports of parents, staff or students using drugs

Any response to drug related incidents needs to balance the needs of the individual student concerned with the wider school community.

Exclusion from school is not always an automatic response to a drug incident, however exclusions will be used depending upon severity or repeat offences, and permanent exclusion is considered in serious cases where:

- There is a serious breach or persistent breaches of our Drugs and/or Achievement and Positive Behaviour Policy and
- Allowing a student to remain in The IMAT would seriously harm the education, safety or welfare of the student or others in the relevant school.

A member of the Leadership Group will be responsible for co-ordinating the management of drug-related incidents, offering sources of support and liaising with outside agencies. Incidents will be dealt with after making an assessment of the situation and will be reported to the Headteacher. All incidents and responses will be recorded within 24 hours.

Appropriate support will be offered to those with substance related problems. Talking with an individual about a drug related incident will have as its purpose to confirm or reject suspicions or allegations, rather than conduct a wider investigation.

### **Drug Misuse outside the school premises**

In line with Behaviour & Discipline in Schools 2016, the school may impose sanctions on a student for misusing drugs outside schools when students are:

- taking part in any school-organised or school-related activity or
- travelling to or from school or
- in some way identifiable as a student at the school.

The school may also impose sanctions on a student for misusing drugs, or where there is a suspicion that a student is under the influence of drugs, at any time, whether or not the conditions above apply, if the misuse:

- could have repercussions for the orderly running of the school or
- poses a threat to another student or member of the public or
- could adversely affect the reputation of the school.

### Individuals in possession of drugs

If any student or adult on school premises is found in possession of an unauthorised drug it will be confiscated, if possible. If the drug is suspected to be illegal, the school will contact a police officer for discussion and advice. Illegal substances will be handed to the police to be legally destroyed as soon as possible and not stored. Parents/carers will be informed (unless for safeguarding reasons this is not in the best interests of the student) and other professionals such as the LA, Young Offenders Service, Police, GP, Social Services will be informed or consulted as appropriate.

### Confidentiality

The IMAT will always seek to work with parents and carers when information or allegations of drug use are made. There may be occasions when, for safeguarding reasons, this may not be appropriate (please refer to our Safeguarding and Confidentiality policies for more information on this).

Complete confidentiality can never be promised to a student. In particular if a student chooses to disclose that they are using a drug without medical authorisation, this information will not be used against them. However, action will be taken to try to ensure the student comes to no serious harm if this is considered a risk. Regarding disclosures staff will follow the advice given in the Safeguarding Policy, and at the annual safeguarding training updates.

### **Support for students**

At the IMAT the welfare of the student is paramount and intervention will be made if the relevant school feels a student is showing signs which indicate particular risks of, or from, involvement with drugs, whether their own or the involvement of their parents'/carers'. Such interventions may include:

- Support and advice in school (Student Support, Year Head, Form Tutor, other designated pastoral staff)
- Referral to specialist outside agencies for support
- Involvement of the police

### **Right to Search**

In line with legislation the staff (within the IMAT) reserve the right to search students if they have reason to believe that they are carrying offensive weapons or illegal substances. Similarly, students can expect to be physically restrained if they present a danger to themselves or other members of the community.

Searches will be carried out by members of the relevant Leadership Group and key pastoral staff and parents/carers will always be informed when this has happened.

If inappropriate articles are brought into school or used inappropriately, they may be confiscated and kept in the school safe for collection at the end of the day. If these items are dangerous or illegal, they will be handed to the police for safe disposal.

The IMAT works closely with its Police Community Support Officers. If students are involved with any activity which breaks the law the police will be involved in the confiscation of items, group work and education as well as links with home. Parents/carers will always be informed when the police are involved and given the opportunity to attend any interviews.

Similarly, the police will be involved if any student is suspected of having contact with an illegal substance. This includes possession, using or dealing. In such cases, the police will decide what course of action should be taken.

### **Monitoring and Evaluation**

The Staff Sub-committee of the MAT Board will formally review this policy every two years or more frequently if circumstances or legislation suggest it is appropriate.
